

## TOWNSHIP OF BRUCE

### MINUTES OF REGULAR MEETING HELD ON JULY 13, 2017

The regular meeting of the Bruce Township Board was held on July 13 at the Bruce Township Hall with board members Rogers, Pins, Marsh, LaJoie and Sawyers present. Also in attendance were six township residents. The Supervisor called the meeting to order at 7:00 p.m. with the Pledge of Allegiance.

Public Comments: There were no comments.

The minutes of the June 8, 2017 meeting were presented. Motion was made by Pins, seconded by Marsh to accept the minutes as presented. All were in favor, motion carried.

Motion was made by Pins, seconded by LaJoie to pay the bills. Checks # 9285 through # 9320 were issued for a total of \$ 48,050.03. All were in favor, motion carried.

County Commissioner Report: Commissioner MacLean was not present.

Reports of Special Meetings: The Supervisor attended a meeting in Petoskey.

Zoning Administrator: There have been 14 permits issued.

Assessor Report: The July Board of Review will be held on Tuesday, July 18, 2017 at 7:00 p.m.

Planning Commission Report: The Commission is working on square footage for residential homes and set back lines for plotted areas,

Treasurer's Report: The Treasurer's report was read. The balance of all funds is \$758,958.36.

Clerk's Report: The routine water test shows nothing detected. The cost of Spring Clean-Up was \$1,350.00 with 90 Vouchers being used.

Firemen's Report: The Department had 3 fire calls. There are 23 members in the Fire Department. The Fire Chief asked about putting an automatic primer on the Pierce Fire Truck. Motion was made by Pins, seconded by Marsh to have an automatic primer put on the Fire Truck. All were in favor, motion carried.

Grounds and Park Report: There has been brush clean out at Dunbar Park. There is always grass to be cut.

Old Business: Scenic Drive Road is done. West 12 Mile Rd. will be started around the first of August.

We are still waiting on some results on what needs to be done for the Donaldson Cemetery. There is still no clear deed.

There is no information on the website.

New Business: Discussion was held on marking the lines on the Parking Lot. It was decided to wait until the addition to the parking lot is paved and get it all done at the same time.

Land Division was presented for John and Lannie Castagne on 14329 Scenic Dr. Motion was made by Pins, seconded by Marsh to accept the land division for the Castagne's. Motion carried.

Land Division was presented for Carol Bourque on 3488E. 9 Mile Rd. Motion was made by LaJoie, seconded by Pins to accept the land division for Carol Bourque. Motion carried.

Public Comment: There was a thanks for the dirt for the flower bed.

Motion was made by Pins, seconded by Rogers to adjourn the meeting. All were in favor, motion carried. The Supervisor adjourned the meeting at 7:30 p.m.
